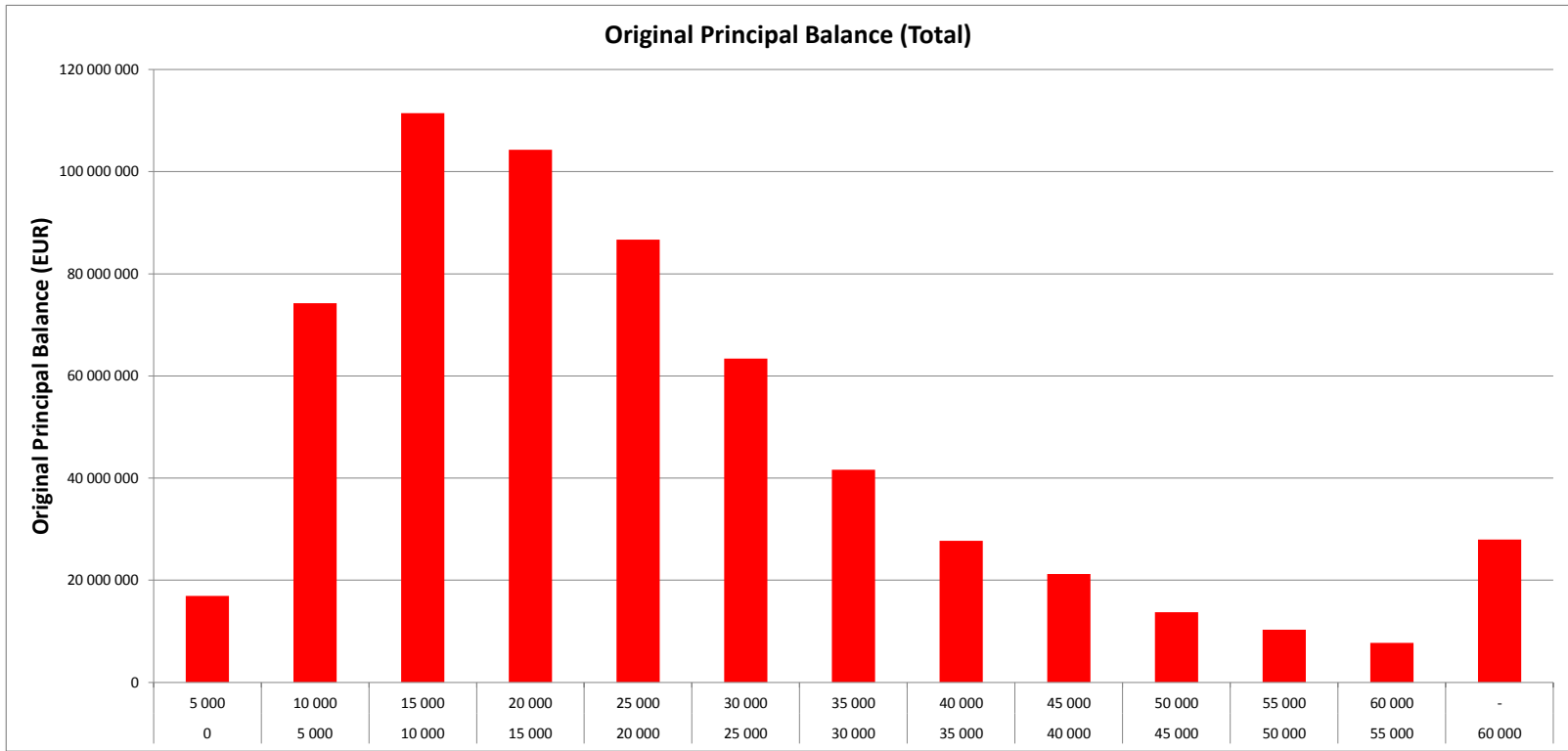

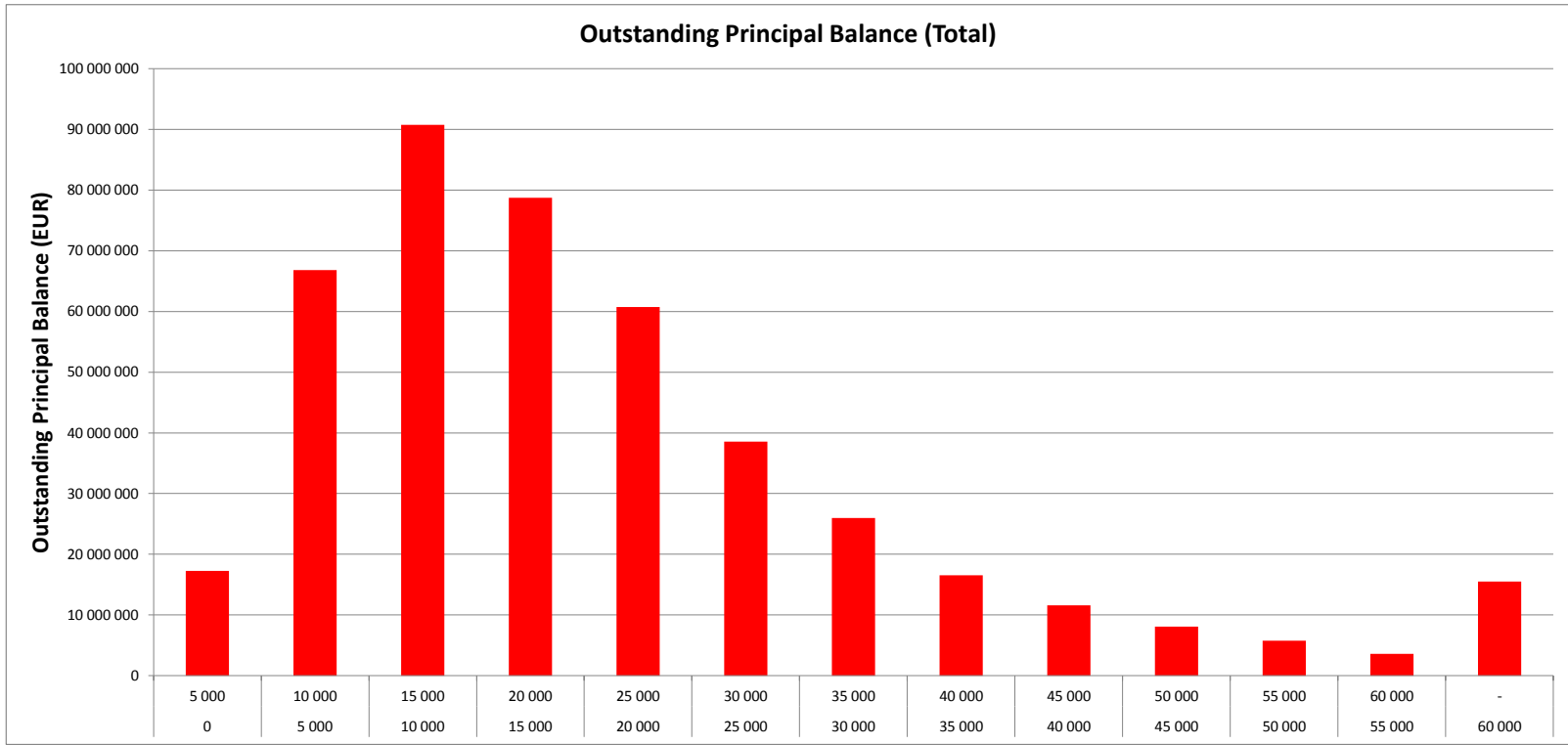

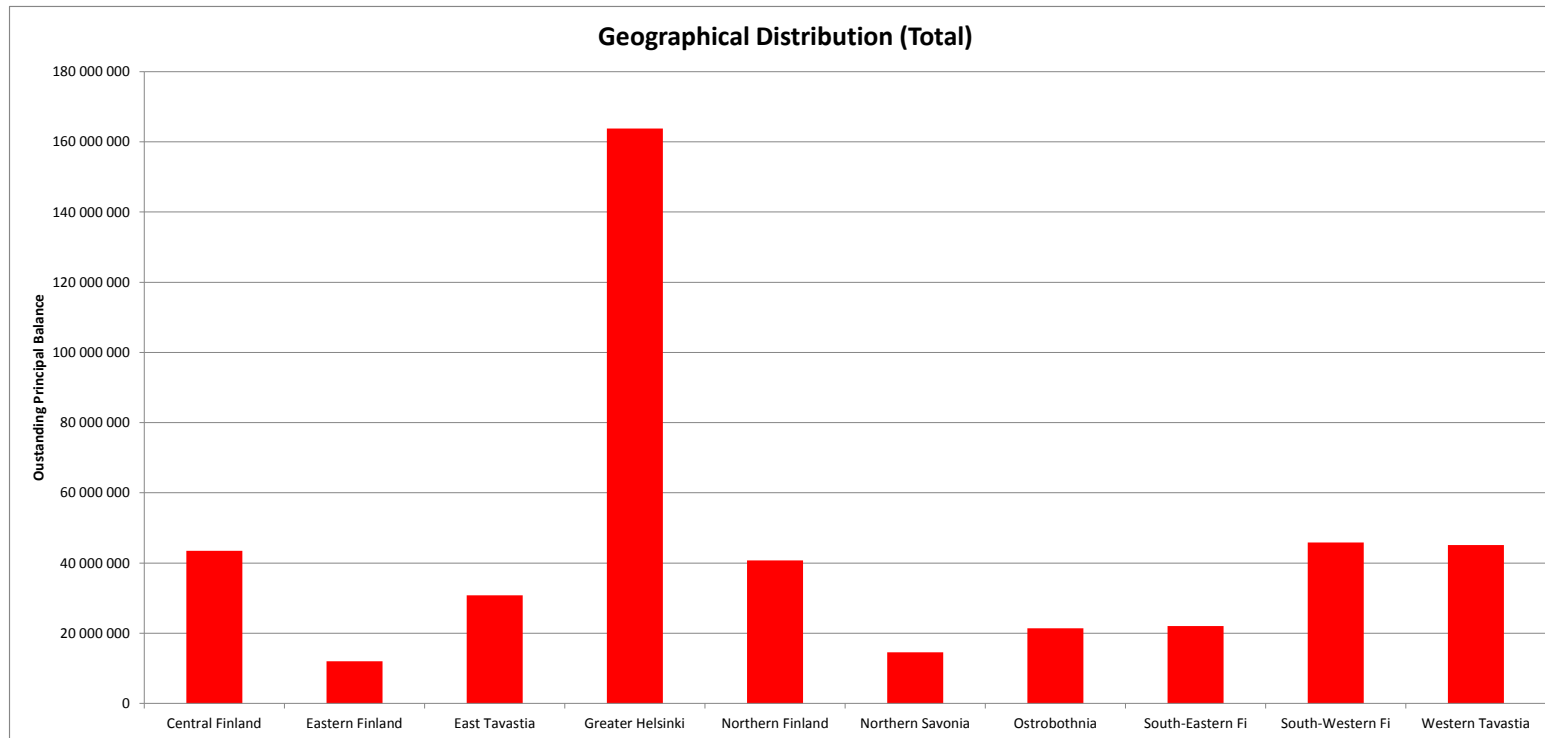

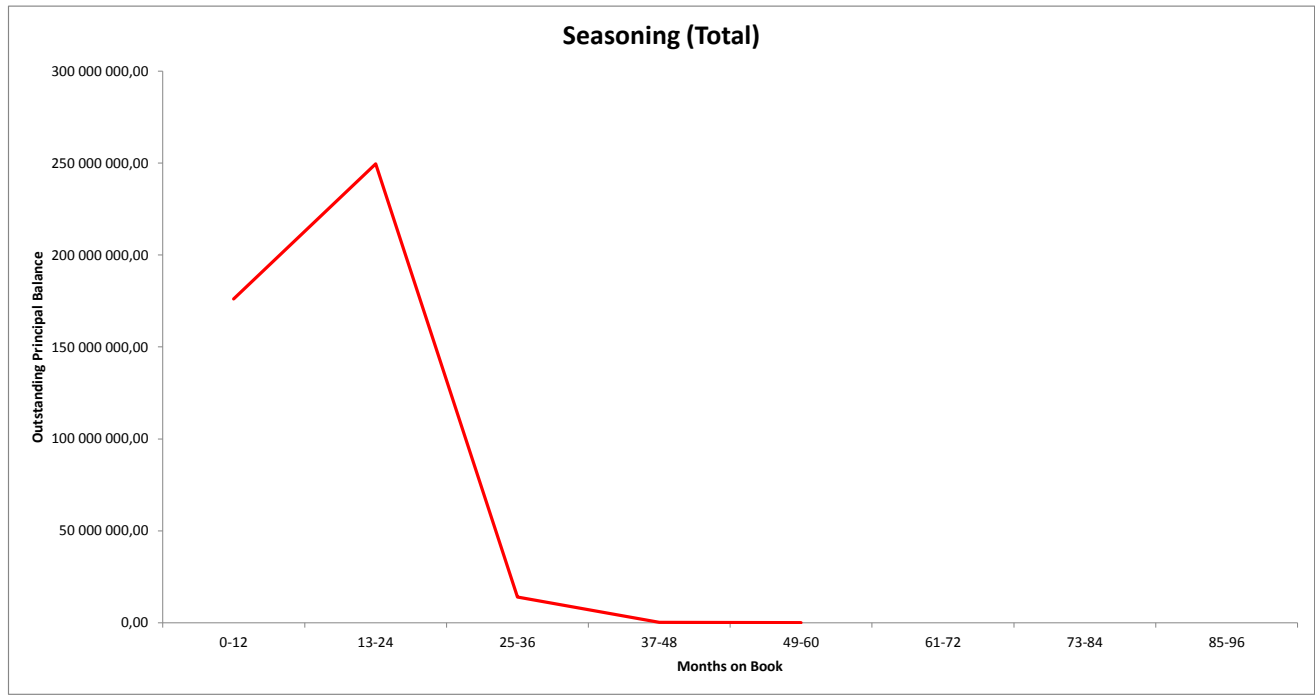

Amortization profile (first 20 periods)

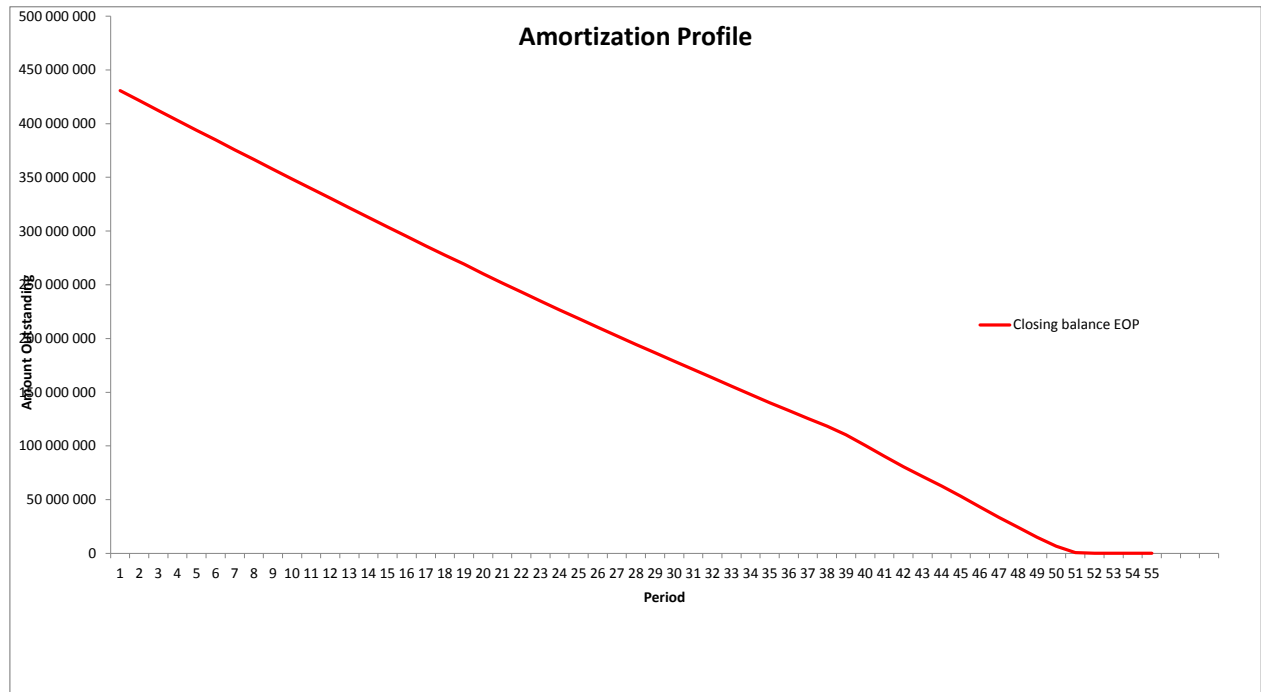
